Approval of Agenda with Amendments: Motion by Frei; Second by Reader to approve agenda with amendments: Item D: 229 Lakeview Ct is owned by the City, Add Item J: Consideration for new copier for City Hall office. Add Item K: Consideration to open campground from October 16 thru December 31. All voting aye, motion carried.

Public Comment: Benjamin Seago, Regional Manager of APM Mosquito Control, presented information on the season's mosquito control. Karen Blatt thanked Hines for getting the information out concerning the information from the MI EDC concerning the Federal Grant that the state is about to give to be used in the Community Development, there were many good presentations at the meeting at K of C Hall on September 15<sup>th</sup> and with the leadership we have in Beaverton that we are moving forward. Clifford Monaghan inquired as to who is responsible for the trees in the right-of-way between the sidewalk and the road. He stated that there is a tree in front of his property that is potentially dangerous if high winds come thru. Is the homeowner responsible for removing large trees. If so, he wanted a copy of the ordinance that states that. Hines gave information that we are collaborating with the attorney to find out what we can do to take care of several trees in town that need to be taken down. Karl Hauser, on ballot for the Board of Trustees for Mid-Michigan College, spoke about his background and why he was running.
