- G. Motion by Danielak, second by List to approve Land Bank to submit grant for Blight Property Access for Ross Park bath house, Doane St. cement pad and Fassett property. All voting aye, motion carried

H. Motion by Danielak, second by Reader to appoint Scott Govitz as interim City Manager so council can move forward on hiring DPW staff and wage determinations if necessary. All voting aye, motion carried
