### Resolution Establishing Rates for Water Service

**WHEREAS**, the City of Beaverton Ordinance Title II, Chapter 24, Section 2.403, as Amended, requires the Beaverton City Council to establish by Resolution the rates to be charged for water service; and

**WHEREAS**, the City Council has determined that an increase in water rates is necessary in order to adequately fund the operations of the City Water System;

**NOW, THEREFORE, BE IT RESOLVED** that the following rates are established for charges to be paid by users of water service provided by the City of Beaverton effective on July 1, 2022 (FY 23): Charges billed bi-monthly:
